Practice Times

Practice is an important process of the pageant. Please make plans to attend.

What to wear.....

Dress to practice is casual; however, you may want to bring shoes you will wear in the pageant to practice.

What to bring.....

During the first practice, please bring a sponsor fee of \$55, information sheet, and media release. The information sheet will be read by the emcee during the pageant, please write neatly.

What we'll be doing.....

Practice #1 Entry fees, contestant information sheets, and media releases will be taken up. Picture and Video Order forms will be made available. Order of appearance will be randomly drawn. Contestants will receive a number to wear at every practice. Walking on stage and introductions will be practiced. Be sure to include the name of sponsor during introduction. No introductions will be made during evening gown appearance. Miss Congeniality will be explained to contestants. **Group picture for The Messenger fair supplement will be taken this night at practice.**

Practice #2 Scoring information will be reviewed. Participants will practice introductions and walking. Contestants will also be introduced to comparative judging.

Practice #3 Introductions, turns, and announcement of winners will be reviewed. Participants will pick up t-shirt to wear for interview (\$10 cash only). Stage will be decorated and sound system available for this rehearsal.

Interviews

Fairgrounds and Convention Center

Interview time depends on contestant number drawn, and begins at 3:00 pm. Interviews will be held at the Convention Center. More information to be announced.

What to wear.....

A **kelly green** t-shirt will be available on Monday, July 27 at practice. The cost will be \$10. Bring cash to purchase the t-shirt. The t-shirt is for interviews and casual wear. It must be worn tucked in. There will be absolutely no altering of shirt. The contestant will **wear khaki Capri's** and white tennis shoes. A belt or sash is optional and is left up to the discretion of the contestant.

Stage Appearances

Hopkins County Fair Grounds and Convention Center

(Contestants will be allowed in free of charge and will receive two passes for admittance only. No Drive-In Passes will be issued. Please park in normal parking and use the passes to gain entry. No contestant will be allowed to drive in the fairgrounds even for loading/unloading.)

Dressing Room (6:00 – 7:00 pm no earlier than 6, no later than 6:45 pm)
Upon arrival, check in, receive your number to wear and vote for Miss Congeniality.

Due to lack of space, please abide by the rule of only one person with the contestant in the dressing room at a time. No assistants and/or parent behind the stage in the Midway Building at any time.

Pageant (7:00 pm)

At 6:55 pm contestants will line up in numerical order at the back of the stage.

Sportswear Attire Portion

Contestants will show in the Kelly green shirt, khaki capris, and white tennis shoes for their first stage appearance.

Evening Gown Portion

Please choose a long, age-appropriate evening gown.

Scoring

Scoring is based upon a score sheet consisting of 30 points for interview, 30 points for casual wear, and 40 points for evening gown.

Comparative judging will be held in groups of 12, if 36 girls are participating.

Awards

Awards include Winner, 1st Runner Up, 2nd Runner Up, and Miss Congeniality. Miss Photogenic will not be awarded this year. The winner must be willing and able to attend the 2009 Miss Pre-Teen Kentucky County Fair Pageant. It will be Friday and Saturday, October 16 & 17, 2009 at the Crowne Plaza in Louisville, Kentucky.

Photography & Videography

Forms for both will be available at the last practice. It will contain the photograph previously submitted for the newspaper, and photography/ videography forms and other information.
